1. PHOTO SUBMISSION

- A. Each photographer may submit up to three images between February 15th and May 15th, 2008
- B. Each print has to be submitted in an 8X10 size
- C. Each photograph submitted needs to have the CONTEST SUBMITTAL FORM (located at the bottom of this sheet) filled out completely and attached to the corresponding print
- D. Photographs can be submitted in black and white or color
- E. Entries need to be mailed or hand delivered to:

2. CONTEST RULES/GUIDELINES

- A. Each contestant may submit up to three (3) images (prints only).
- B. Photo’s submitted may be recent or copies of old photo’s of Country Kids
- C. Approval of parent or guardian of children under 18 is necessary
- D. Each photo must feature one or more kids as the subject in a portrait, candid or action setting with a country theme
- E. Size: 8X10 print, unmounted and unframed
- F. Photos may be black & white or colored but NOT be digitally painted
- G. Printing paper Choice—Non glossy are preferred , but glossary prints will be accepted.

Judging will be based on general appeal, composition, creativity , artistic & technical quality. Hints: lower sunlight and using the 1/3 rule will assist in general appeal and composition categories, but is not necessary to win. Overall general appeal category will have the most weight when judging is done. Winners of the contest will be selected by a panel of jurors . The decision of the jurors is final. Winners will be notified.
